#### Pastor's Pen

When they had finished breakfast, Jesus said to Simon Peter, "Simon, son of John, do you love Me more than these?" He said to Him, "Yes, Lord; You know that I love You." He said to him, "Feed My lambs." He said to him a second time, "Simon, son of John, do you love Me?" He said to Him, "Yes, Lord; You know that I love You." He said to him, "Tend My sheep." He said to him the third time, "Simon, son of John, do you love Me?" Peter was grieved because He said to him the third time, "Do you love Me?" and he said to Him, "Lord, You know everything; You know that I love You." Jesus said to him, "Feed My sheep. Truly, truly, I say to you, when you were young, you used to dress yourself and walk wherever you wanted, but when you are old, you will stretch out your hands, and another will dress you and carry you where you do not want to go." (This He said to show by what kind of death he was to glorify God.) And after saying this He said to him, "Follow Me." (John 21:15-19) As I write this, our school is arriving at the end of their Spring break. By the time you read this, the children will have come back to their regularly scheduled classroom activities. Except that that's not entirely true this year. This year, Easter came early. School resumed right in time for Holy Week. So the children got about three days of regular school time before having time off for Good Friday and Easter Monday.

What this means in practical terms for the school children (and the school staff), is that we're going to have a solid two months for the final quarter of school. There will be no more long breaks, and no more long weekends to look forward to—with the exception of Memorial Day, but that's during the last week of school anyhow. Once Easter is over, it's a whole lot of "business as usual."

In some ways, that's what it seemed like shortly after the very first Easter. Jesus rose again from the grave on the third day, and He appeared to ten of the disciples in the upper room. Thomas was not with them on that day, but one week later, Thomas was with the rest of the disciples, and Jesus appeared once again. John concludes the narrative of Jesus appearing to the eleven disciples by writing: "Now Jesus did many other signs in the presence of the disciples, which are not written in this book; but these are written so that you may believe that Jesus is the Christ, the Son of God, and that by believing you may have life in His name" (John 20:30-31). It would seem as if all that Jesus was sent to accomplish in this world has now been completed. It's the end of the story.

But it's not really the end of the story. Not long after this, the disciples tried to get back to "business as usual." They went back to Galilee, and Peter said that he was going fishing. Six other disciples fished with him, but they caught nothing all night. As dawn was breaking, a man called out to them from the shore and asked if they had caught anything. When they said that they had not, that man bid them to cast their nets on the right side of their boat. As soon as they did, the net was full of fish. Then they recognized that that man was their Lord.

After coming to the shore and eating breakfast with Him, Jesus began to ask Peter if he loved Him. He did this three times, and each time Peter confessed that he did indeed love Jesus. And each time, Jesus bid Peter to care for His sheep. This interaction between Jesus and Peter did two things. First, this was Jesus' restoration of Peter. Peter had denied that he even knew Jesus three times. Now, Peter has confessed three times that he loves Jesus. Peter is forgiven of his cowardice and betrayal, and he is restored as the foremost of the disciples.

The second thing this interaction accomplished is that it re-defined "business as usual." After following Jesus for the intense three-year time period of His earthly ministry, hearing His many teachings, witnessing His many miracles, being sent out themselves to proclaim the kingdom, seeing Him handed over into the hands of sinful men to be killed, and now raised from the dead, the disciples were about to begin a period of ministry that would not be like those three years. There would be much teaching and preaching. There would even be miracles. But they were going to be in it for the long-haul.

Their new normal, their new "business as usual," was to feed Jesus' sheep. Their task, for the rest of their lives, was to be witnesses of Jesus to the world. They were to go and tell all peoples that Jesus of Nazareth is the Christ, the long-awaited Messiah, who had died for the sins of the world and had been raised to give new and eternal life to all who believe in Him.

As another Easter comes and goes for us, we see that this is also our new normal. This is our "business as usual." The season of Lent, and especially Holy Week, is a time of increased intensity, both in our public worship life together, and in our personal devotional lives. Lent is a very special time in the Church Year, but it's only six weeks long. It's not meant to last all year. It's not meant to be business as usual. The new normal for Christians is to live in that post-Easter reality, the reality in which our sins are forgiven by Christ, we have new and eternal life in Him, we have received this by faith, and so we gladly go and tell others about Him.

We are not like the apostles in every way. We were not eyewitnesses of Jesus' life, death, and resurrection. Not all of us are going to be sent to the far reaches of the world to preach to foreign people groups. But we do follow in the footsteps of the apostles, telling others what they testified of. In our day-to -day lives, with our families, friends, co-workers, and sometimes even strangers, we share the hope that is in us. We tell of what Christ has done. We tell of how He won for us forgiveness of sins, and how He has given us new and eternal life. This is our post-Easter reality. This is our new normal. This is our "business as usual." Amen.



I thought it would resurrect after a night on the charger. It didn't. My alarm went off so I had hope. But I couldn't turn off the quacking. And the quacking continued for a full half hour and every nine minutes after that. ALL morning.

## Stewardship

### Whose Is It Anyway?

If you have every bought or sold a house, you are acquainted with the concept of a "title search." Before you can sell your house, and before anyone else will feel comfortable putting down the money to buy it, you have to prove that you really own it. So a title company looks through the public records to ensure that you bought it from the person who really owned it, who bought it from the person who really owned it before that, all the way back to the earliest records of your state, including when your state was only a territory or colony of England.

Peak into a preschool classroom during playtime and you'll see a simplified version of this. A child starts playing with a ball, but another child says, "That's mine: I had it first."

You can't understand the Seventh Commandment without understanding this concept of ownership or title. As the Small Catechism puts it:

You shall not steal. What does this mean? We should fear and love God so that we do not take our neighbor's money or possessions, or get them in any dishonest way, but help him to improve and protect his possessions and income.

Your neighbor's possessions are *his*: you don't have a right to take them. And likewise, your possessions are yours. Ownership and property rights are foundational to any functioning society.

But there is something deeper to know about ownership, and that is the question of who has the title and ownership to you? Paul says, "Or do you not know that your body is a temple of the Holy Spirit within you, whom you have from God? You are not your own, for you were bought with a price" (1 Cor. 6:19-20).

If you yourself are owned by God, then of course everything that you own, you really only possess by God's leave: all of it, at bottom, belongs to Him since *you* belong to Him. For you were bought with the blood of Christ.

This notion is the foundation of all Christian stewardship. It all belongs to God. It should all be used for things that bring honor to His name, blessings to our neighbors and the extension of His kingdom.
